SOLUTIONS is the actual Internet-based interactive report that I provide to my Clients. You get to see all my insurance and legal disclosures, my CYA language for site-specific conditions, the various educational documents I have written (such as my extensive document on the laundry area), how the interactivity works in linking to other documents and information on the Internet, and, most importantly for marketing purposes, how it provokes a “Wow!” response by my Clients when they first open **SOLUTIONS**. And once my Clients see how much information I provide to them, they are encouraged to come back to me whenever they need information... or another property inspection, thereby ensuring that my company name is in front of them every time they think about homes.

SOLUTIONS is mainly a significant collection of PDF files that are introduced with a short PowerPoint presentation that plays automatically on any computer running Windows 98 or later.

There are two different versions of SOLUTIONS available only to NACHI members:

- 1 For a \$10 processing fee, you get a complete copy that is security protected (this is the default that I provide to my Clients). Although the design and content of **SOLUTIONS** are copyrighted by my company, as well as being security protected, you, as a NACHI member, should feel free to use, modify, or adapt anything in it to fit your needs and to help you provide great service to your Clients. However, since it is security protected, if you see something that you want to use, you will have to retype it or dictate it to your voice recognition software.
- 2 At the suggestion of several NACHI members who have security-protected copies of **SOLUTIONS**, I am now making available a complete copy of **SOLUTIONS** that has ALL of the Word files that I have created and which were used to create the security-protected PDF files. That means that you can open the Word files and edit them for your own needs—copy and paste information elsewhere, use the files with appropriate modifications for your company, etc. With the editable Word files, you can use **SOLUTIONS** as your own report system, you can use it as a supplemental educational system, or you can simply use individual documents in it however you see fit, perhaps as public service announcements to get published and get your name out there through the print media. The unprotected version of **SOLUTIONS** is provided at a cost of \$99, which includes **FREE UNLIMITED SUPPORT** by me to help you modify files for your needs. You will also get a **FREE SIX-MONTH SUBSCRIPTION** to [About Homes](#), a \$99 value. Your six-month subscription includes **250 FREE DOWNLOADS**, so you can add documents to your **SOLUTIONS** disk as you see fit. If you already are a subscriber to [About Homes](#), I will simply add the 250 free downloads and six months to your current subscription. You can also use those downloads to provide free subscriptions to [About Homes](#) for your Clients, as several NACHI members already are doing.
